Return to Learn Plan

2020-2021

Before School

Personal health screenings are an extremely important practice to keep Wyman Elementary students and staff safe and to prevent sick individuals from coming into the building. This can be done by parents screening students before they ever start school at the beginning of the day. Please refer to the specific expectations outlined in the Rolla Public Schools Return to Learn Plan.

Arrival at School

- Car riders will begin exiting cars at 7:30 am and supervised by Wyman personnel. Car riders should have face coverings on as they exit the cars.
- Bus riders will exit their bus at 7:35 am. Bus riders should have their face covering on as they exit their bus.
- Students will go immediately to their classroom once the doors open at 7:35 am.
- Students needing to eat breakfast at school will be eating breakfast in the classroom.

During School-The school day officially starts at 8:05 am

- Students will be required to wear a face covering when social distancing (6') is not an option.
- Students will be required to wear a face covering during passing times and in the halls when social distancing isn't possible.
- Students will not be required to wear face coverings when with their cohort.
- Students receiving Title 1 services or Special education services while not in their cohort will be required to wear a face covering.
- Hand sanitizer will be available for students when hand washing is not available.
- Students should have individual school supplies to work with throughout the day.
- Students will wash their hands frequently throughout the day.
- Students will be allowed to have water bottles in the classroom.
- Restrooms will be routinely sanitized throughout the day.
- Special area classrooms will be sanitized after each class to the greatest extent possible.

Lunch

- One grade level will be housed in the cafeteria at any one time.
- Cohorts will have assigned seating and be socially distanced while in the cafeteria.
- Students will wash their hands prior to going to the cafeteria.
- Students will wash their hands after their lunch time.

Physical Education

- Physical education activities will take place outside as much as possible.
- Physical education equipment will be sanitized to the greatest extent possible after each class.

Library

- Open AR time will not be available on an individual basis.
- Students will be allotted more books to check out during library time. Check out amounts are dependent upon grade level.
- All returned books will be quarantined for 72 hours prior to being reshelved.

Nurse

- Students not feeling well will be directed to see the nurse.
- Students with a fever will be quarantined to the greatest extent possible from other students and staff until the parent arrives.
- Please refer to the Rolla Public Schools Return to Learn plan for more information regarding specific procedures for students with a fever.

After Bell Care

- After Bell Care students will be required to wear a face covering when social distancing is not possible.
- Outdoor activities will take place to the greatest extent possible.
- Frequent hand washing will take place.

Visitors

- Visitors entering the building must have a face covering.
- Non-essential visits will not be permitted beyond the main office area to limit exposure to groups of students and staff.
- Essential visits are defined as those necessary for the education and social/emotional wellness of students and staff.

Dismissal

- Students will be escorted to the car rider room and bus room in their cohorts.
- Students will be required to wear a face covering if social distancing within the hallway is not possible.
- Car rider students will sit in cohorts which are socially distanced within the gym.
- Bus riders will be required to wear a face covering because they will not be with their cohort.
